
Legislative Director Kenneth E. Grabowski discusses the Lansing Legislative Reception at Troppo on February 24, 2010.

The event was a great success heavily attended by numerous State Representatives. POAM discusses endorsements during the upcoming elections.


7. Motion to Adjourn.
