Disclaimers:

- Pending ratification from POAM and the approval of the Board of Commissioners, this agreement will become effective April 6, 2020.
- Employees in classifications currently on the Professional, Technical and Administrative (PTA) Schedule will receive the agreed upon PTA Schedule rates effective on the first pay in April 2020, and the first pay of each year thereafter for the remainder of the contract.
- Employees in classifications on the expired contract's pay schedule shall be considered 'Red-Circled'.
- Red-circled employees will not receive base wage increases past the maximum rate of the expired contract's pay schedule, unless increases to the PTA Schedule result in an increase to that employee's base wage.
- Should the PTA Schedule result in an increase to a red-circled employee's base wage, they shall be integrated onto the PTA Schedule and advance to the next closest step within the pay grade designated for that classification, effective the first pay in April 2020, or the first pay of the year should this occur in 2021 or 2022.
- After the effective date of this agreement, newly hired employees, as well as current employees who promote, laterally transfer, or voluntarily demote into any classification, shall receive the wages based on the pay grade associated with the PTA Schedule.
- Eight (8) employees in the classification of Assistant Prosecuting Attorney IV will be moved to Principal Trial Attorney by Classification Seniority effective the first pay in April 2020.
- The classifications titled Assistant Prosecuting Attorney I and Assistant Prosecuting Attorney III from the expired contract will be retitled based on the employer proposed pay grade spreadsheet and will be placed on the 2020 PTA Schedule.

LUMP SUM LANGUAGE:

- Full-time red-circled employees will receive a one-time lump sum payment of \$1000.00 for each year of the contract, including the year they are no longer considered red-circled.
 - Lump Sum Payments will be made as follows:
 - First pay in April 2020
 - Second pay in January 2021
 - Second pay in January 2022

This agreement and all other provisions of this agreement shall remain in effect until December 31, 2022.
